

Terms of Use Agreement

1. General.

1.1 This Agreement governs the use of the N-CAST shapefile. The shapefile and the information it contains are provided as a service to the user by ATRI under contract DTHF61-07-C-00019 to FHWA, Office of Freight Management and Operations. Unauthorized attempts to access or modify any information located on this shapefile, to defeat or circumvent security measures, or to use this system for other than its intended purposes are forbidden and may result in termination of USER access and use .

1.2 ATRI reserves the right, in coordination with FHWA, to change or modify all or any part of this Agreement at any time, effective immediately upon notice published on the N-CAST site.
